	Teachers and students are expected to be active participants in asynchronous and synchronous virtual learning. Teachers will provide students with opportunities that foster social engagement (discourse) through written assignments or synchronous sessions. Whether in an asynchronous or synchronous session, students should experience opportunities to interact with other students and their teacher on a daily basis.
